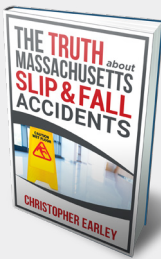

It's All About the Team



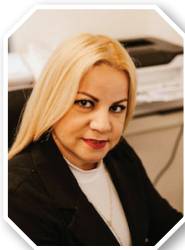

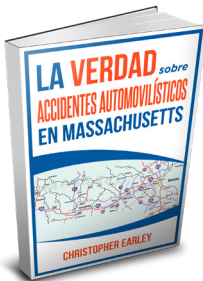
